

**V CALL OF THE “ARAR” RESEARCH PROGRAM OF THE CLINICAL VIROLOGY AND  
ZONOSSES GROUP OF THE MAIMONIDES BIOMEDICAL RESEARCH INSTITUTE OF  
CORDOBA (IMIBIC)**

**1. Aim**

The objective of this call is to incentivize and promote the mobility of young and emergent researchers from countries outside Europe to conduct a fellowship in the Clinical Virology and Zoonoses research group of the IMIBIC. The program aims at establishing an interaction between the IMIBIC and the center of origin of the researcher through joint research projects, facilitating the acquiring of skills and updating of knowledge by the applicant. In the same way, this program will promote the establishment of new links between both institutions, fostering a stable and permanent collaboration.

This call is open to researchers of any nationality working at institutions in any country **outside of Europe**, with the exception of The United States of America, Canada, Australia, New Zealand, South Korea and Japan. Restrictions apply also to researchers coming from countries or entities that are currently under any type of restriction to participate in EU funded programmes as described in [https://ec.europa.eu/info/funding-tenders/opportunities/docs/2021-2027/common/guidance/list-3rd-country-participation\\_horizon-euratom\\_en.pdf](https://ec.europa.eu/info/funding-tenders/opportunities/docs/2021-2027/common/guidance/list-3rd-country-participation_horizon-euratom_en.pdf).

**The priority research line for this call** is “Emerging and re-emerging viral diseases”

**2. Scope**

This call is open to researchers who work in research centers from countries outside of Europe (see above for details and applicable restrictions). Applicants should be enrolled in doctoral programs or have obtained their PhD in the last three years prior to the call

deadline. The applicant will integrate in the Clinical Virology and Zoonosis research group. The fellowship will have a duration appropriate to the project proposed by the applicant, but in any case of no more than 3 months.

### **3. Conditions**

The Clinical Virology and Zoonoses research group of the IMIBIC will assume the whole cost of:

- Travel from the Institution of origin to the IMIBIC.
- Accommodation and living expenses of the fellow during the fellowship.
- Insurance costs.
- Cost of the research project, including laboratory consumables, samples shipment, translation of papers and abstracts...
- Cost derived from the applicant formation (workshops, seminars and courses for specific training).

A fixed-amount living allowance will be established according to internal rules at IMIBIC.

Fellows will sign a sworn declaration of the expenses and provide the corresponding receipts and/or invoices.

### **4. How to apply**

## **5. Timetable**

Call will open from 28 October 2024 up to 31 December 2024 (23:59h, CET).

## **6. Evaluation process**

The evaluation and selection process has the following phases:

- Eligibility check by the Research Support Service
- Evaluation of CV and Project proposal by the principal investigators of the Clinical Virology and Research Group.

## **7. Appointment of selected applicants**

The evaluation process will take place during **January 2025**. The final decision will be announced personally by email to the selected applicant and published in the IMIBIC website.

## **8. Acceptance and obligations of the beneficiary**

The beneficiary undertakes to comply with the conditions of the present call and to present to the IMIBIC a final report of the fellowship in to the first 6 months after completion of the project.

## **9. General policies**

The funds to cover the present call will be provided by the Clinical Virology and Zoonoses research Group of the IMIBIC. IMIBIC will manage the cost of travel, accommodation and living allowance of the fellow. The Clinical Virology and Zoonoses research Group of the IMIBIC will manage the cost of the research project, including the preparation, translation and publication of manuscripts resulting from the abovementioned project. The Clinical Virology and Zoonoses research Group of the IMIBIC will also manage the training costs of the applicant.
